It is hereby ordered, adjudged and decreed, that the prayer of the petitioner be, and the same is hereby granted, and that J. A. Christopher, E. J. Meiners, and Julius W. H. Hadermann, three disinterested freeholders of Umatilla County, State of Oregon, be and they are hereby appointed as viewers, and J. W. Kirtrell as surveyor, to view, locate and lay out a road as in this petition prayed for.

and it is hereby further ordered, adjudged and decreed that the said viewers and surveyor shall meet at the beginning of said proposed road on the 27 day of November, 1899, at the hour of ten o'clock A.M. of said day, and proceed to lay out, locate and establish a road thirty (30) feet wide, in accordance with the petition, and to assess the damage sustained by the said Harriet Hansen, Andy Larsen and Tars Hansen, by reason of the laying out, locating and establishing of the said County road, as aforesaid, according to law, and report their proceedings to this Court, at the January term thereof, in the year 1900, and that they duly qualify before entering upon the discharge of their duties in this behalf, and that a copy of the petition, together with a copy of this order be served upon each of the parties hereinbefore named, to-wit: Harriet Hansen, Andy Larsen, and Tars Hansen, within four (4) days after the making of this order.
