

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN THAT A PUBLIC HEARING WILL BE HELD BY THE UMATILLA COUNTY BOARD OF COMMISSIONERS ON MARCH 16, 1994, AT THE HOUR OF 10:00 A.M., IN ROOM 114 OF THE UMATILLA COUNTY COURTHOUSE IN PENDLETON, OREGON, FOR THE PURPOSE OF CONSIDERING THE VACATION OF A PORTION OF W. 4TH STREET IN THE WEST 1/2 OF SEC. 27, T5N, R28 E.W.M., SOUTH OF POWER CITY, WEST OF HWY 395, EAST OF THE UMATILLA RIVER, AND NORTH OF HERMISTON, APPROXIMATELY 4 MILES NORTH OF THE CITY OF HERMISTON, UMATILLA COUNTY, OREGON, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

THAT PORTION OF THE WEST 1/2 OF SEC. 27, T5N, R28 E. W.M., UMATILLA COUNTY, OREGON, BEING DESCRIBED AS FOLLOWS:

BEGINNING AT THE S.W. CORNER OF BLK. 27, CHARLES TRACTS, AND RUNNING; THENCE N $11^{\circ}20'30''$ W ALONG THE WEST LINE OF SAID BLK. 27 A DISTANCE OF 80.80 FEET; THENCE CONTINUING ALONG SAID WEST LINE N $10^{\circ}27'45''$ W 453.17 FEET TO THE N.W. CORNER OF SAID BLK. 27; THENCE S $79^{\circ}33'15''$ W ALONG THE WESTERLY PROJECTION OF THE SOUTH LINE OF ROBNETT ST. 60.00 FEET TO A POINT ON THE WEST LINE OF W. 4TH ST.; THENCE S $10^{\circ}26'45''$ E ALONG SAID WEST LINE OF SAID STREET 453.64 FEET; THENCE CONTINUING ALONG SAID WEST LINE S $11^{\circ}20'30''$ E 81.17 FEET TO A POINT ON THE WESTERLY PROJECTION OF THE NORTH LINE OF KIK STREET; THENCE N $78^{\circ}39'30''$ E 60.00 FEET TO THE POINT OF BEGINNING.
