If you answered Yes, STOP you can qualify to apply as an Oregon Resident and do not need this form. Bring proof of the Owned or Leased Property.

### Qualifications:

Submitting this form ATTACHED to your Umatilla County Sheriff's Office Concealed Handgun License Application indicates you are requesting a "waiver of residency requirements" from the Sheriff of Umatilla County for an Oregon Concealed Handgun License (CHL). By submitting this form you understand issuance of a CHL to a non-resident applicant is at the discretion of the Sheriff. You MUST demonstrate a compelling business interest or other legitimate demonstrated need that is specific to Umatilla County. The Sheriff is under no obligation to grant a residency waiver request and reserves the right to deny the request to any out of state applicant.

1. Do you currently live in a state that borders Oregon?  YES  NO

If you answered No; STOP. You will not qualify under Oregon Law.

If you answered Yes, PROCEED with the form (make sure your Driver's License shows your resident address)

2. Can you demonstrate a compelling business interest?  YES  NO

If you answered No, PROCEED to question #3.

If you answered Yes; EXPLAIN in DETAIL below (Attach additional documents if more space is needed)

Explanation examples: You are employed in Umatilla County or Your business requires you to visit Umatilla County. List the specific work and employer information, including addresses and contact information please.

3. Can you demonstrate a legitimate need by listing **activities** performed **in Umatilla County**?  YES  NO

If you answered No to BOTH #2 and #3, PROCEED to NOTE section below.

If you answered Yes, EXPLAIN in DETAIL below (Attach additional documents if more space is needed)

Explanation examples: (List specific locations and/or addresses) I visit relatives living in Umatilla County. I frequently recreate at locations in Umatilla County. I frequently shop at locations in Umatilla County. Note: "I visit Pendleton Round-up" or I "Go to the Casino" will not be accepted.

**NOTE: You must be able to answer YES to either Question # 2 or Question # 3, otherwise you will NOT be considered for a residency waiver.**

**ATTENTION:** If you have been convicted of a **drug crime** or a **crime involving domestic violence** you will NOT be considered for a residency waiver. **Negative entries** on your criminal history background could also result in a **denial** of residency waiver request, even if you would otherwise qualify as an Oregon resident. If denied, application fee is non-refundable.
